

**AMENDMENT TO THE
PROGRAMMATIC AGREEMENT AMONG
ARLINGTON NATIONAL CEMETERY,
THE VIRGINIA STATE HISTORIC PRESERVATION OFFICER, AND
THE ADVISORY COUNCIL ON HISTORIC PRESERVATION
FOR THE OPERATION, MAINTENANCE, AND REPAIR ACTIVITIES AT
ARLINGTON NATIONAL CEMETERY
ARLINGTON COUNTY, VIRGINIA**

WHEREAS, the Programmatic Agreement (hereinafter the “PA”) was executed on February 6, 2025; and

WHEREAS, in accordance with Stipulation XIII.C. of the PA, within sixty (60) calendar days prior to the date the PA would otherwise expire, Arlington National Cemetery (hereinafter “ANC”) consulted with the Virginia State Historic Preservation Officer (hereinafter the “SHPO”) and the Advisory Council on Historic Preservation (hereinafter the “ACHP”), which are Signatories to the Agreement, and requested the Signatories consider an extension of the PA; and

NOW, THEREFORE, in accordance with Stipulation X (Amendment) of the PA, ANC, the SHPO, and the ACHP agree to amend the PA as set forth below:

1. Amend and replace Stipulation XIII (Duration of Agreement) in its entirety to read as follows:
 - A. This PA shall remain in full force and effect for one (1) year after execution of this Amendment in order to allow for continued consultation on drafting a new PA. The new PA shall include updates to ANC property boundaries, archaeological research, operations and maintenance policies and practices, and Attachments A-F. The new PA, upon execution, shall supersede the terms of this amended PA.
 - B. Sixty (60) calendar days prior to the date this PA would otherwise expire, ANC shall consult with the Signatories to determine whether the PA needs to be extended, amended, or terminated and take such actions as appropriate.
